- B. The Commission may undertake such additional checks or seek any additional information before granting any applicant a license, including additional checks with enforcement authorities within Malawi.
- C. The Commission may share details about operators and relevant persons with enforcement authorities in Malawi, and on request with other Government Departments and their agencies.
- D. This application form with appropriate proof of identity documents, documents demonstrating financial standing, proof of tax compliance, and any other attachments specified, shall together constitute the application.
- E. The application is valid only within the application period prescribed by the Commission.

Conditions for licensing

Granting of this license is subject to the following conditions: -

- i. All buyers shall participate in buying tobacco through both contract and auction marketing (67(3))
- ii. To be responsible for hiring and making payment for the transportation of tobacco from estate to tobacco floors for contracted tobacco.
- iii. To buy only on licensed tobacco floors.
- iv. To buy a minimum of 500,000 kilograms tobacco (green weight) either as a single tobacco type or a composite of all types
- v. To declare inter-traded tobacco details.
- vi. To maintain all requirements as per section 67 and any other requirements relevant in the Act and subsidiary regulations.
- vii. The buyer shall upon application and authorization, re-sell not more than 10% of the floor purchase.
- viii. To be subjected to specific penalties with respect to specific violations in line with the provisions of the Act and subsidiary regulations.
- ix. To furnish returns regarding the condition, quantity and quality of tobacco purchased at the end of the season and as may be requested by the Commission from time to time.
- x. To pay levies as outlined in the Act, regulations and government Notice Number 2.
